STEPS TO INTRODUCE, READ, MOTION & VOTE ON A CENSURE RESOLUTION IN YOUR REPUBLICAN LEGISLATIVE DISTRICT MEETING

OPTION A: Add the Censure to the Agenda ahead of your LD Meeting

- 1. Call your LD Chair, send a signed copy of the Censure resolution to your LD Chair via email & request the Censure to be added to the agenda.
- 2. Request your LD Chair to send a signed copy of the Censure resolution via email to your entire Republican Legislative District Committee. (All PCs would receive a copy using this method)

OPTION B: Introduce/Read/Motion/Vote on Censure in New Business

- 1. Bring Physical Copies of your Censure resolution. You need enough copies of the Censure resolution for the Precinct Committeemen in attendance of your Legislative District Meeting.
- During your Legislative District Meeting, You need to raise your hand or stand up to say "Mister/Madame Chair, I have a resolution that I would like read/introduce under new business."
 - a. You will do this during new business or at an appropriate time during your LD Meeting.
- 3. The Chair has the option of either allowing you to proceed to read/introduce the resolution OR by asking the Precinct Committeemen in the Legislative District Meeting:
 - a. You must be a Precinct Committeeman to read/introduce the Censure, and if you are not a Precinct Committeeman, only a Precinct Committeemen can allow a non-PC to speak. If you are a Non-PC, ask a Precinct Committeemen to introduce you.
 - b. "Do I have a 2nd on the question to introduce the resolution?" Precinct Committeeman can 2nd the motion. The Chair will then ask "all those in favor say: I "All those oppose say: No. "The I's appear to have, do have it, so ordered."
 - c. If a NO vote occurs to read the censure resolution, any Precinct Committeemen can say: "I call for the Yeas/Nays. A Roll call vote."
- 4. Read Censure Resolution, beginning to end. (Do not summarize. Read entire Censure)
- 5. After you read the Censure, the LD Chair will ask "Any discussion?"
 - a. Each side For/Against receives a total of 5 minutes of debate.
 - b. There is some discretion of the LD chair to extend time if needed.
- 6. Debate Completes.
- 7. Next the LD Chair will ask "Do I have a 2nd to agree on the censure resolution?"
- 8. Precinct Committeemen says "I 2nd the motion."
- 9. The Chair will then ask "all those in favor say: I, all those oppose say: No. "
- 10. If there is a No vote, any Precinct Committeemen can say: "I call for the Yeas/Nays. A Roll call vote. "

- 11. Vote begins on the Censure Resolution.
- 12. Once Vote completes the LD Executive Committee will report back to the Chair on the results of the vote.
- 13. If there is not a "No "vote or objection, the Censure Resolution passes Unanimously.
- 14. Finished!
