1 Be it resolved by the Republican Precinct Committeemen of the

4 WHEREAS, Ben Toma/Warren Petersen is a Republican Arizona State
5 Representative/State Senator who is refusing to uphold their oath of office in
6 A.R.S 38-231;

7 WHEREAS, Ben Toma/Warren Petersen is refusing to defend the laws of the State
8 of Arizona and the Constitution of the United States;

9
10 WHEREAS, under the authority of Republican AZ State legislature, AZ state
11 legislature's legal council wrote a false " Mueller Report " style Memo against
12 our fight to protect election integrity and against our fight to prevent
13 election fraud, in a salacious attempt to confuse our wonderful AZ citizens &
14 our spectacular AZ Precinct Committeemen on what the Republican AZ state
15 legislature is refusing to do which is fight for election integrity and get
16 tough on Hobbs;

17 WHEREAS, the citizens commanded 56th Arizona state legislature to protect &
18 enact election integrity with notices on January 1st, January 14th, February 1st
19 2023 by ordering the AZ state legislature to compel compliance of AZ election
20 law in Arizona Revised Statutes Title 16, by adding an exception to any
21 County's (including Maricopa county's) state shared revenue and ensure at least
22 3 meaningful election integrity bills are on the negotiating table & signed by
23 the AZ Governor before appropriating all monies to the AZ Governor's 9th floor
24 in the AZ state annual budget;

25 WHEREAS, AZ State Speaker of the House Ben Toma/AZ State Senate President
26 warren Petersen on November 15, 2022 re-appointed Rusty Bowers' Chief of Staff
27 Michael Hunter for the AZ State House;

28 WHEREAS, On March 16th 2023 it was publicly stated on the Mike Broomhead show by
AZ State Senator Steve Kaiser (LD2) that zoning reform in SB1117 is the most
important bill to the 2023 56th Republican AZ State legislature: " this is the

1 most important bill of the session, “ per AZ State Senate President Warren
2 Petersen;

3
4 WHEREAS, United States Constitution Article 1 Section 4 Clause 1, United States
5 Constitution Article 2 Section 1 Clause 2, is the highest and supreme law of
6 the land in the State of Arizona and the United States of America on elections
7 which granted the AZ State legislature their responsibility & authority of
8 elections and the AZ State legislature is in charge of elections;

9 WHEREAS, Maricopa county as the operator of the elections and a civil division
10 of the state does not have 14th amendment rights to USURP the AZ state
11 legislature’s federal/state Constitutional authority of elections;

12 WHEREAS, in this current 2023 AZ State 56th legislative session; there are
13 several Republican AZLeg members who have sponsored SB1137 – “ Maricopa county;
14 division; new counties, “ & SB1137 single’s out Maricopa County dividing it up
15 into 4 new Maricopa counties, 4 Maricopa Counties would mean 4 new Bill Gates,
16 4 new Stephen Richers, 4 new Jack Sellers and 4 new Scott Jarretts, all *mostly*
17 under the same AZ election laws from 2020/2022, as a reminder under the
18 authority of Republican AZ State legislature, AZ state legislature’s legal
19 council memo 03/15/2023 falsely stated its unconstitutional to single out
20 Maricopa County;

21 WHEREAS, the AZ state legislature has the vested legislative authority (power
22 to make laws), writes the state annual budget (power of the purse), disburses
23 money to Counties as state shared revenue, sets the times places and manner of
24 holding elections; appoints US Presidential electors for Arizona, has state
25 house/state senate chambers, both state house and state senate make their own
26 rules, also during each AZ state legislative session the AZ state legislature
27 can change, amend or repeal their own rules at any time of their choosing with
28 a simple majority vote;

WHEREAS, Article 4 Section 4 “ guarantee a Republican form of government, “ in
our Republic within our pledge of allegiance;

1 WHEREAS, Arizona State Constitution Preamble, Articles 1 and 2, specifically
2 establishes all political power to the people, fundamental principles essential
3 to the security of individual rights/free government & that these powers are
4 inherent to the people;

5 WHEREAS, Arizona Constitution Article 2 Section 21: All elections shall be free
6 and equal, and no power, civil or military, shall at any time interfere to
7 prevent the free exercise of the right of suffrage and Arizona Constitution
8 Article 7 Section 7: In all elections held by the people in this state, the
9 person, or persons, receiving the highest number of legal votes shall be
10 declared elected;

11 WHEREAS, Maricopa County violated the Arizona State election
12 laws/procedures/statutes, performing misconduct in maladministration & election
13 fraud that impacted the outcome of both general elections of 2020 and 2022;

14 WHEREAS, Arizona Revised Statute 42-5029 subsection D states: “ Of the monies
15 designated as distribution base, the department shall: 2. Pay 38.08 percent to
16 the counties in this state by averaging the following proportions: The
17 proportion that the population of each county bears to the total state
18 population, “;

19 WHEREAS, the Arizona State annual budget includes the Arizona state shared
20 revenues which are distributed to all 15 counties of AZ, and voted on by all
21 AZ State Representatives and all AZ State Senators by invoking Arizona Revised
22 Statute 42-5029 subsection D in the written text of the AZ state annual budget;

23 WHEREAS, Arizona State Constitution Article 9 Section 5, states “ No money
24 shall be paid out of the state treasury except in the manner provided by law,”
25 and in Article 9 Section 20 states the legislature inherently sets the
26 “ expenditure limitation.....for each county, “;

1 WHEREAS, the people with all political power, inherently reserves the right to
2 hold our 56th Arizona state legislature accountable for their failure to serve
3 the citizens of Arizona;

4 WHEREAS, AZ State Speaker of the House Ben Toma/AZ State Senate President
5 Warren Petersen, is refusing to follow the Constitutional
6 orders/demands/commands of their citizens and Republican Voters of the
7 _____ Republican Club in _____ County, AZ;

9 **Be it Resolved**, the Republican Voters of the _____ Republican Club in
10 _____ County, AZ, censures
11 AZ State Speaker of the House Ben Toma/AZ State Senate President Warren Petersen.

17 bills are on the negotiating table & ***signed*** by the AZ Governor ***before*** appropriating
18 all monies to the AZ Governor's 9th floor in the AZ state annual budget, We the
19 Republican Voters of the _____ Republican Club in
20 _____ County, AZ will not support, campaign, donate, fundraise or
21 vote for AZ State Speaker of the House Ben Toma/AZ State Senate President Warren
22 Petersen who doesn't represent the great people of the _____ Republican
23 Club in _____ County, AZ or the citizens of the State of Arizona.
